1. **Purpose:**The purpose of the Business Leaders Circle is to provide a customized professional development opportunity for one to share business issues, challenges and experiences with other business professionals in a relaxed, confidential setting.
2. **Structure:** Each Circle will consist of up to 12 members representing non-competing businesses, with an appointed facilitator to lead and direct the Circle’s activities. The Circle will meet once monthly at an agreed upon location.
3. **Commitment:** Each member agrees to join the Circle for a commitment of at least one-year. Members will provide advice, participate in discussions, and provide input towards improving the knowledge of each member. A member is strongly encouraged to maintain a 70% attendance rate in a calendar year in order to insure continued growth of the program. A member can be asked to leave the BLC if the request is not met. If a member becomes inactive his/her application for membership may be resubmitted at the next induction period.
4. **Confidentiality:**Members will respect the confidentiality of what is discussed in each meeting. If a member violates the confidentiality of the Circle their Circle membership will immediately be terminated with no opportunity for resubmission.
5. **Eligibility:** Business representation may include an owner, principle, partner, general manager, president, vice-president, executive director, independent contractor or other policy and decision maker of the business. Applicants must have at least two years business experience. Final determination of eligibility rests with the Business Leaders Circle members.
6. **Monthly Meetings:** Each group will meet monthly at a designated time and place as determined by their group members. A group may choose to have a rotating host. A host would be predetermined for each meeting and would be responsible for securing an appropriate place to meet, having refreshments available. The host would provide a 10-minute business “showcase” to discuss the specifics of their company.
7. **Facilitator:** The Facilitator will notify the membership of the meeting date, time and place; assist the Host, lead the meeting, and will report the activities of the Circle to the BLC Executive Committee.
